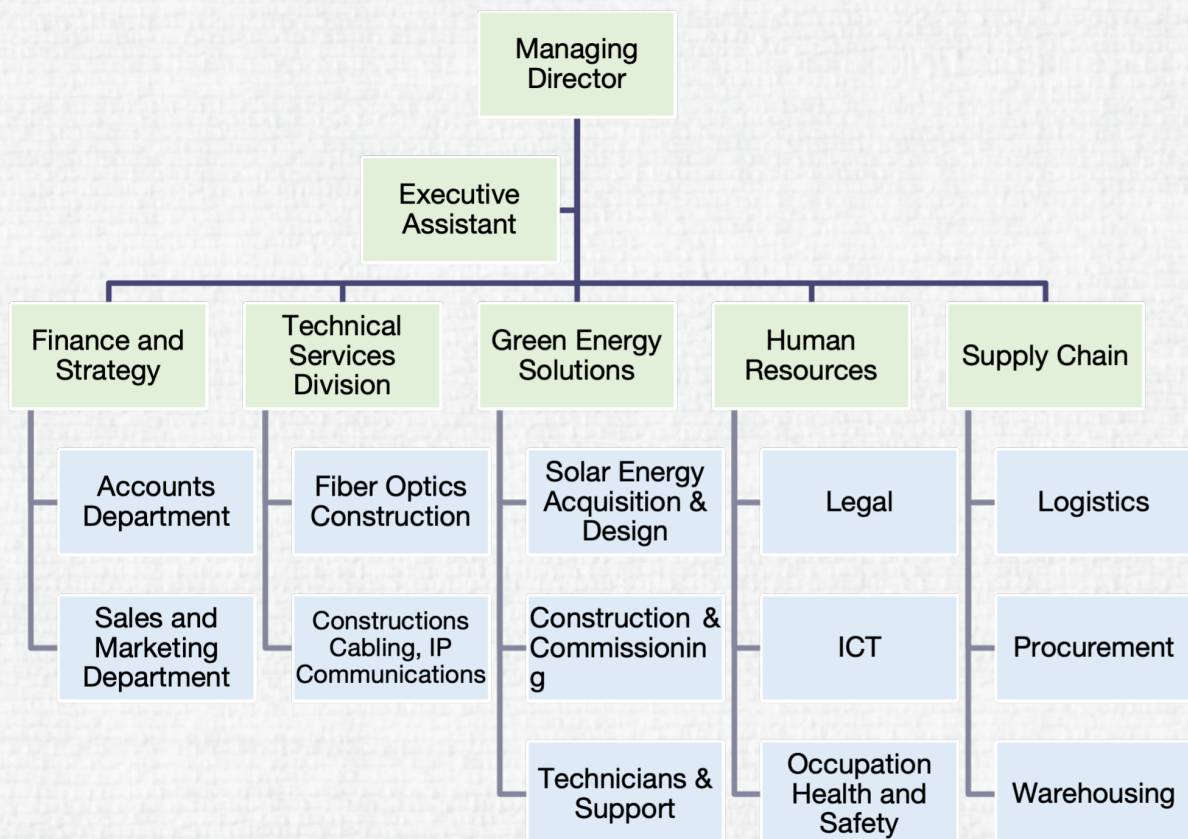


Our **Team/Organization Structure**

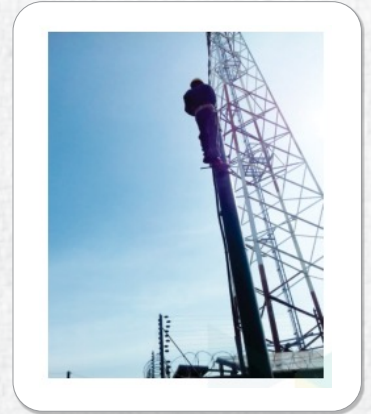

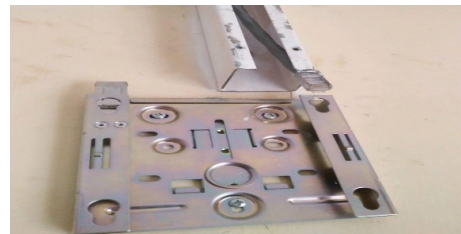
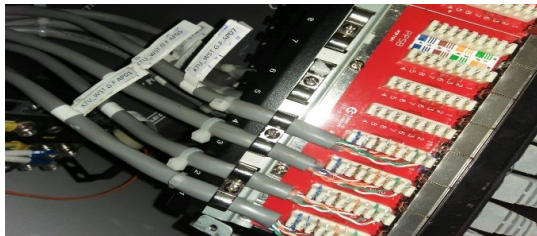
Fiber **Optics**
